SEGMENT DESCRIPTIONS

The data elements that make up the LIBRS data structure are grouped into eighteen (18) segments and three (3) levels.

The first level includes the Submission Header and the Submission Trailer Segments. There should be one Submission Header Segment at the beginning of an agency's data and one Submission Trailer Segment at the end of an agency's data.

In level 2 a Zero Records segment is used if the agency does not have incidents to report for the reporting period. The second level also includes the base segments for an incident. Each incident's data is grouped together and defined using a combination of level 2 segments and level 3 segments.

The third level is the data expansion level. This level of records is used to collect multiple occurrences of a data field or group of fields under each level 2 segment.

This arrangement of multiple level segments is being used to eliminate the collection limits and the wasted data space in the current system that is caused by blocking repeated data elements in groups of ten (10) or less.

Submission Header Segment: A level 1 segment contains classification information about the data being submitted. There must be only one Submission Header Segment record for each agency's submission. This segment must be the first record in the submission.

Administrative Segment: A level 2 data segment provides administrative information regarding the overall incident.

Administrative Modification Segment: A level 3 data segment allows an unlimited number of Louisiana Revised Statutes to be listed. This segment is to be used when the Administrative Segment is being update or modified, and will indicate which offenses are being exceptionally cleared. This segment is only used when the original incident is not on the state database (Action Type must be "W" = Time- Window Submission).

Offense Segment: A level 2 data segment includes information about an offense within the incident.

Property Segment: A level 2 data segment is used to submit information regarding property affected by the incident.

Property Description

Segment:

A level 3 segment allows unlimited property descriptions to be submitted. This segment is to be used for all property, including seized drugs.

Property Modification

Segment:

A level 3 data segment allows an unlimited number of Louisiana Revised Statutes to be specified. This segment is to be used when property has been recovered. This segment shows the original offense for which the property is being recovered when the original incident report is not on the state database (Action Type must be "W" = Time-Window Submission).

Offender Segment:

A level 2 data segment lists suspected offender(s).

**Offender Using Segment/
Gaming Motivation:**

A level 3 data segment contains codes for the "Offender Suspected of Using/**Gaming Motivation**" data element.

Victim Segment:

A level 2 data segment contains information about the victim of the incident.

Victim Injury Segment:

A level 3 data segment is used to indicate the types of injuries a victim sustained.

**Victim/Offender Relation
Segment:**

A level 3 data segment shows the victim to offender relationship.

Arrestee Segment:

A level 2 segment lists persons arrested for commission of offenses within the incident.

Arrestee Armed Segment:

A level 3 data segment allows the listing of an unlimited number of armaments possessed by the arrestee.

Arrestee Statute Segment:

A level 3 segment indicates the statute(s) with which an arrestee is charged.

**Arrestee Modification
Segment:**

A level 3 data segment allows an unlimited number of Louisiana Revised Statutes to be specified. This segment is to be used when an arrestee is being submitted for an incident that is not on the state database (Action Type must be "W" = Time- Window

Submission or "M" = Modify if Time Window has already been submitted and needs to be modified).

Submission Trailer Segment: A level 1 data segment contains summary information about the data being submitted. There must be only one Submission Trailer Segment for each agency's submission. This segment is labeled 99 and must be the last record in the submission.

Zero Records Segment: A level 2 data segment indicates the agency has no crimes to report to LIBRS for the given reporting period. This is confirmation to the system that the data submission is blank and not missing.

DATA ELEMENTS CONSISTENCIES

Data Element Numbers: Data elements are numbered using a three (3) character alpha format.

Straight numeric data element numbers are NIBRS (National Incident Based Reporting System) numbers that have carried over to LIBRS, or they are LIBRS data elements that closely follow the corresponding NIBRS data elements.

Data element numbers followed by an alpha code (i.e. 8A) are additions from NIBRS that have carried over to LIBRS.

Data elements that are preceded with an "L" (i.e. L26, L47) are unique to LIBRS.

Data elements preceded with a "C" are NOT true data elements. They do not relate to the incident data. They are "Control" data elements that are used to identify and control the large volumes of data coming into the State Program. They are internal to the state system.

Date Formats: All dates are to be in the following format: MMDDYYYY

All dates submitted to the state system will follow this format unless otherwise noted.

Date/Time Formats: In fields where date and time are reported together, they are to be formatted as follows: **MMDDYYYYXHH**. Hours are to be in the twenty-four (24) hour format.

All date/time submitted to the state system will follow this format unless otherwise noted.

Numeric Formats: Numeric fields are to be right justified, and must contain leading zeros to preserve column alignment. Values of less than zero will be indicated by immediately preceding the number with a minus "-" sign. In the absence of a minus "-" sign the LIBRS system is to assume a number to be a zero or greater.

Alpha Formats: Alpha fields are to be left justified, and must contain trailing spaces (ASCII Code 32, EBCDIC Code 40) to preserve column alignment.

Alpha/Numeric Formats: **This edit type also allows for blank fields when offense (Quote Numeric Paragraph) does not allow a data value in this data element.**

Blank Fields Definitions: When data elements are "empty" they are to be filled with spaces (ASCII Code 32, EBCDIC Code 40). This indicates the elements were intentionally left blank. Filling "empty" fields with any other character (including zeros) will cause LIBRS to return the submission with errors

SAMPLE OF DATA ELEMENT DEFINITIONS:

Note: Updates from LIBRS Release 1.1 to Release 2.0:

Any updates, clarifications or additions being made from LIBRS Release 1.1 to LIBRS Release 2.0 will be identified in "**bold**" letters. This has been done to readily identify any updates or adds so that an agency that has already begun implementing LIBRS can make any programming updates that might be needed.

DATA ELEMENT # 00 **This line contains the number and the name of the data element. Even though the Data Element Number and description are indicated in "bold", only the portion underlined would indicate any updates to the description.**

EDIT TYPE: This line describes the variable type used to store that data element in the LIBRS computer.

Numeric allows numbers and decimal points. Do not include decimal places unless specifically asked for in data element description.

Alpha/Numeric allows alpha characters, numbers, decimal points, and negative signs. Do not include decimal places unless specifically asked for in data element description. This edit type can also allow blanks to be sent when offense does not require a data value.

Date allows numbers only. Date fields also check that the value represents a valid date. Dates are to be entered as Month, Day, Year, and are to be formatted as follows: MMDDYYYY. Month and day values which are less than ten (10) should be preceded with a leading zero (0) to preserve column alignment. Years must also include the century.

Alpha allows any printable character.

When field must be blank, do not enter zeros.

FORMAT: This line describes the exact format of the data element. It is only included when necessary.

REQUIREMENTS: This line describes when a value is required for this data element. Since LIBRS is an affirmative reporting system, most elements are required. Most required elements contain a value

for "UNKNOWN", but they are still required. This is because the state system makes no assumptions about missing data. Making no assumptions protects the data reported by the local agencies from being misinterpreted by the state system. (The state system returns numeric error codes for any data requirement violations. The error codes for a particular requirement are listed in parentheses after that requirement and are based on data element edits.)

NOTE: The numeric codes listed below requirements are edits specific to this data element requirement. There are many more edits, error messages and warnings that are edits related to mandatory, global and offense related segments. These error messages and warnings are listed in the LIBRS Error Message Manual, but only some of these are referred to under each data element in this manual.

When your agency begins testing, a copy of the LIBRS 2.0 Error Message Manual will be provided upon request.

Each LRS code has been assigned an alpha/numeric code which indicates which offense the LRS code will be reported to NIBRS (National Incident Based Reporting System maintained by the FBI) for publication in Crime in the United States.

The LRS codes that are applicable for a data element will be listed within each data element. Some data elements will require certain data values and these will also be listed within the data element.

NOTES: This lines explains the data element. It will explain formatting, what data this includes, what it is used for, or when to use it.

ALLOWED ENTRIES: This line shows all the valid codes that can be used within the data element and when they can be used. If more than one code applies to a situation, use the most specific one. (Example: a Circle K Store could be described in data element # 9 (Location Type) as a "05" = Commercial/Office Building, "07" = Convenience Store, or "12" = Grocery/Supermarket. However, since "07" = Convenience Store is the most specific description, it should be used.

EXAMPLES: This section describes different situations and how to handle them. It is to clarify the use of the data element.

EDIT TYPE: 12 Character Alpha

- REQUIREMENTS:**
- 1) Must be present -- cannot be blank.
(Error Messages 10001, 11001, 12001, 13001, 14001, 15001, 16001)
 - 2) Zero Reporting Segments (Segment 01) must contain twelve zeros as the incident number.
(Error Message 10092)
 - 3) Must be left justified with blank right-fill if under 12 characters in length.
(Error Messages 10016, 11016, 12016, 13016, 14016, 15016, 16016)
 - 4) Valid character combinations can include A-Z, 0-9, hyphens, and/or blanks.
(Error Messages 10017, 11017, 12017, 13017, 14017, 15017, 16017)
 - 5) Must be blank right-fill if under twelve characters in length. The field cannot have embedded "Blanks" between the first and last characters entered.
(Error messages 10015, 11015, 12015, 13015, 14015, 15015, 16015)
 - 6) This field must be unique for each incident reported by the agency. This means that no two incidents can have the same incident number. Some agencies ensure uniqueness by prefixing every incident number with a two-digit year followed by a number starting with 1, while others just increment the number by one for each new incident.
(Error Message 10056)
 - 7) Cannot have duplicate incident number for "Time-Window" Segment.
(Error Message 10087)**

NOTES: This is the reporting agency's unique, in-house assigned case number. This data element is used to link update submissions to the original submission. This number will be encrypted prior to any dissemination of data to ensure that the recipient cannot identify the actual case.

DEFINITIONS: **Concept of time and place provides: If more than one crime was committed by the same person or group of persons and the time and space intervals separating them were insignificant, all of the crimes make up a single incident.**

An incident is considered as one or more offenses committed by the same offender or group of offenders acting in concert at the same time and place.

Acting in concert requires that the offenders actually commit or assist in the commission of the crime(s). The offenders must be aware of, and consent to, the commission of the crime(s); or, even if nonconsenting, their actions assist in the commission of the offense(s). This is important because all of the offenders in an incident are considered to have committed all of the offenses in the incident. If one or more of the offenders did not act in concert, then there is more than one incident involved.

Same time and place means that the time interval between the offenses and the distance between the offenses and the distance between the locations where they occurred were insignificant.

Normally, the offenses must have occurred during an unbroken time duration and at the same or adjoining location(s). However, incidents can also be comprised of offenses which by their nature involve continuing criminal activity by the same offender(s) at different times and places, as long as the activity is deemed to constitute a single criminal transaction.

Regarding these situations the reporting agency will have to use its best judgment.

DATA ELEMENT # 3 INCIDENT DATE/HOUR

EDIT TYPE: 11 Character Alpha

FORMAT: MMDDYYYYXHH

- REQUIREMENTS:
- 1) Must be present -- cannot be blank.
(Error Message 11001)
 - 2) Each component of the date must be valid; that is, months must be 01-12, days must be 01-31, and year must include the century (i.e., 19xx, 20xx). In addition, days cannot exceed maximum for the month (e.g., June cannot have 31 days). The date cannot exceed the current date.
(Error Message 11005)
 - 3) When an ORI becomes inactive, no incident data may be submitted to LIBRS with an incident date on or after that date. However, adjustments to previously submitted data may be done.
(Error Message 11018)
 - 4) The date cannot be earlier than 01/01/1991 for "I" = Incident Report submissions. This edit will preclude dates that are obviously incorrect since the FBI began accepting data on this date.
(Error Message 11072)
 - 5) When an agency converts from Summary reporting to Incident Based Reporting (IBR) or commences to report LIBRS data, no data regarding an incident previously submitted under the Summary reporting system can be submitted with an incident date later than the date the agency commenced reporting, otherwise it will be regarded as a duplicate submission and be rejected since the Summary System already contains the aggregate data for the months before LIBRS conversion. In other words, if an agency sends IBR data for the first time on 20 September 1995, all dates in data element # 3 for incidents, recovered property, and arrests must be within September, 1995. The exception to this is when EXCEPTIONAL CLEARANCES occur for a pre-IBR incident. In this case, Data Element #3 (Incident Date/Hour) may be earlier than September, 1995, but Data Element # 5 (Exceptional Clearance Date) must be within September, 1995. The State will maintain a table of start dates (base dates) for each local agency. Except for the above example, the State will reject data submitted with an Incident Date for months prior to the agency's start date.
(Error Message 11073)

- 6) The date cannot be later than the year and month the tape represents. (example: The May 1995 tape cannot contain incidents happening later than this date)
(Error Message 11070)
- 7) The **Submission Date (#C3), in positions 23-30**, and the incident date must be valid entries. The state software uses these to determine if the complete incident should have been reported to the state, or if a subset of the segments should have been submitted as "Time Window" submissions.
(Error Message 11075)
- 8) Administrative Segments (Segment 10) submitted with a Segment Action Type of "W" = Time-Window Submission cannot have a date in Data Element # 3 (Incident Date/Hour) which would be a valid date for an Incident. For any subsequent "M" = Modify of a previously submitted "W" = Time-Window Submission, this is also true.
(Error Message 11076)
- 9) Administrative Segments (Segment 10) submitted with a Segment Action Type of "M" = Modify cannot change the date in Data Element # 3 (Incident Date/Hour) of segments which were previously submitted with a Segment Action Type of "I" = Incident Report.
(Error Message 11061)
- 10) Administrative Segments (Segment 10) submitted with a Segment Action Type of "M" = Modify cannot change the Report Date Indicator (position 51 of the segment) of Segments which were previously submitted with a Segment Action Type of "I" = Incident Report.
(Error Message 11062)
- 11) Administrative Segments (Segment 10) submitted with a Segment Action Type of "M" = Modify cannot change the hours in Data Element # 3 (Incident Date/Hour) of Segments which were previously submitted with a Segment Action Type of "I" = Incident Report.
(Error Message 11063)
- 12) If HOUR is entered it must be "00" through "23." Note: If the incident Date occurred at exactly midnight, enter the Incident Date as if the time was 1 minute past midnight. (Example: If the crime occurred at exactly midnight on Thursday, enter Friday's date) and 00 for the hour.
(Error Message 11052)
- 13) If the Incident Date is unknown, use the report date. Indicate a report date with an "R" in the space before the hour. If this is the Incident Date, then leave the "Report" indicator blank.
(Error Message 11051)

NOTES:

This data element is to be used to enter the month, day, year and hours when the incident occurred or started, or the beginning of the time period in which it occurred. "Military" twenty-four (24) hour time is to be used.

If the incident occurred on or between midnight and 0059, enter "00" for the hour; if on or between 0100 and 0159, enter "01" for the hour if on or between 2300 and 2359, enter "23" for the hour, etc.

If the incident occurred at exactly midnight, it is considered to have occurred at the beginning of the next day. Therefore "00" should be entered for the hour, along with the next day's date.

If the incident date is unknown, enter the date of the report with the indicator "R" = Report. Otherwise leave the report column nine (9) blank.

IMPORTANT NOTE: When an agency reaches Certification and Production has begun, please note the following: The "base date" for your agency is the date that your agency starts production and your data is kept on the State's and the FBI's database. If an incident occurred before the agency's "base date", but was not reported to LIBRS until after your "base date" has been implemented; or this incident was already reported in the UCR summary reports, THIS INCIDENT WILL BE REJECTED (Error message 11073). If this happens, contact a member of the LIBRS staff. If this incident was not reported until after your "base date" was implemented, your agency may have to submit an adjusted UCR summary form to capture these offenses.

If the incident hour is unknown, leave the hour blank.

EXAMPLE:

- (1) If a robbery occurred at 9:30 p.m. on July 2, 1989, the entry should be "07021989b21" (where "b" equals a blank).
- (2) If a kidnaping started at 11:30 p.m. on November 1, 1989, and ended at 6:00 p.m., on November 16, 1989, the entry should be "11011989b23" (where "b" equals a blank).
- (3) If the date and hour of the incident are unknown, but the date of the report was March 15, 1989, the entry should be "03151989Rbb" (where "b" equals a blank).
- (4) **If a burglary occurred sometime between 11:15 A.M. on**

June 24, 1997, and 4:30 P.M. on June 26, 1997, the entry should be 06241997b11 (where "b" equals a blank).

Note: When program requires a blank, it must be a blank not a zero.

- (5) If a rape occurred on November 15, 1997, but was not reported until January 15, 1998, this incident would reject if your agency's "base date" is December 1, 1997. This incident would not have been reported on your Return A (or whatever other forms would be applicable) for the month of November or for the month of December of 1997. If your agency would submit this incident to LIBRS with an incident date of 11/15/1997, it would reject. The reason it would reject is because the incident date is prior to the date your agency's data is being kept on-line for the LIBRS and the FBI/NIBRS databases. Since this incident cannot be accepted into LIBRS and has not been reported to UCR summary, an adjustment would have to be made on UCR summary forms that apply.**

DATA ELEMENT # 4 CLEARED EXCEPTIONALLY

EDIT TYPE: 1 Character Alpha

- REQUIREMENTS:**
- 1) Must be present -- cannot be blank.
(Error Message 11001)
 - 2) Must be a valid code.
(Error Message 11004)
 - 3) Cannot be "N" = Not Applicable if Data Element # 5 (Exceptional Clearance Date) is entered.
(Error Message 11053)
 - 4) When a value other than "N" = Not Applicable is entered, there can be no Arrestee Segments associated with the Incident.
(Error Message 10071)
 - 5) Administrative Segments (Segment 10) submitted with a Segment Action Type of "M" = Modify must have an "N" = Not Applicable in Data Element # 4 (Exceptional Clearance Indicator) when arrestees were already present for the incident report.
(Error Message 11064)
 - 6) Administrative Segment (Segment 10) submitted with a Segment Action Type of "W" = Time Window Submission cannot contain an "N" = Not Applicable in Data Element #4 (Cleared Exceptionally).
(Error Message 11054)**

NOTES: This data element is used to indicate whether the incident was cleared exceptionally. In a multiple offense incident the exceptional clearance of one offense, clears the entire incident. An incident cannot be cleared exceptionally if it was previously or at the same time cleared by an arrest, (i.e., if an Arrestee Segment was or is being submitted).

In order to clear an offense by exceptional means, each of the following four conditions must be met:

The investigation must have clearly and definitely established the identity of at least one offender.

and

Sufficient probable cause must have been developed to support the arrest, charging, and prosecution of the offender.

and

The exact location of the offender must be known so that an arrest could be made.

and

There must be a reason outside the control of law enforcement that prevents arresting, charging, and prosecuting the offender.

Do not report exceptional clearance information for justifiable homicide, as no crimes have occurred, in reality.

The closing of a case or the clearing of it by an agency's policy does not permit exceptionally clearing an offense unless all four conditions are met.

ALLOWED ENTRIES: Enter one (1) code for an Administrative Segment.

- A - Death of Offender
- B - Prosecution Declined (by the prosecutor other than lack of probable cause)
- C - Extradition Denied
- D - Victim Refused to Cooperate (in the prosecution)
- E - Juvenile/No Custody (the handling of a juvenile without taking him/her into custody, but rather by oral or written notice given to the parents or legal guardian in a case involving a minor offense)
- O - Other (Administrative Closing of a case--this does not clear the incident for LIBRS--**reported to NIBRS as a "N"**)
- N - Not Applicable (Not Cleared Exceptionally)

EXAMPLE:

- (1) A kidnapper holding a hostage killed himself when the building in which he barricaded himself was surrounded by police. The kidnaping is cleared exceptionally under, "death of the offender".

DATA ELEMENT # 5 EXCEPTIONAL CLEARANCE DATE

EDIT TYPE: 8 Character Date

FORMAT: MMDDYYYY

- REQUIREMENTS:**
- 1) The clearance date cannot be earlier than the incident date.
(Error Message 11055)
 - 2) Must be present if case was cleared exceptionally per data value code in Data Element # 4 (Cleared Exceptionally).
(Error Message 11056)
 - 3) Each component of the date must be valid; that is, months must be 0-12, days must be 01-31, and year must include the century (i.e. 19xx, 20xx). In addition, days cannot exceed maximum for the month (e.g., June cannot have 31 days). The date cannot be greater than that entered within the "Month of Tape" and "Year of Tape" are "06/1995", "the clearance date cannot contain any date 07/01/1995 or greater.
(Error Message 11005)
 - 4) Administrative Segments (Segment 10) submitted with a Segment Action Type of "W" = Time-Window Submission must contain Data Element # 4 (Cleared Exceptionally) and # 5 (Exceptional Clearance Date). Both must be present to be a valid submission.
(Error Message 11057)
 - 5) Administrative Segments (Segment 10) submitted with a Segment Action Type of "W" = Time-Window Submission cannot have an Exceptional Clearance Date (Data Element # 5) earlier than the "Time-Window" Base Date. For any subsequent "M" = Modify of a previously submitted "W" = Time-Window Submission, this is also true.
(Error Message 11020)
 - 6) Administrative Segments (Segment 10) submitted with a Segment Action Type of "M" = Modify with an "N" = Not Applicable in Data Element # 4 (Exceptional Clearance Indicator) cannot have an entry in Data Element # 5 (Exceptional Clearance Date).
(Error Message 11066)
 - 7) Administrative Segments (Segment 10) submitted with a Segment Action Type of "M" = Modify for a previously submitted "W" = Time-Window Submission must have a date in Data Element # 5 (Exceptional Clearance Date).
(Error Message 11067)

- 8) Administrative Segments (Segment 10) submitted with a Segment Action Type of "W" = Time-Window Submission or "M" = Modify cannot have a date earlier than the date the ORI was certified for LIBRS submission. Data Element # 5 (Exceptional Clearance Date), was earlier.
(Error Message 11074)

NOTES:

If an incident was cleared by exceptional means, the month, day and year, when the incident was cleared, is to be entered into this data element.

EXAMPLE:

- (1) The incident was cleared on the books of the reporting agency on May 27, 1989. It was entered into the local computer on June 6, 1989, and was submitted to the state sometime in July of 1989. The date "05271989" should be entered into this data element.

DATA ELEMENT # L6 OFFENSE SEQUENCE NUMBER

EDIT TYPE: 3 Character Numeric

- REQUIREMENTS:**
- 1) Must be present -- cannot be blank.
 (Error Message **12001**)
 - 2) Must be numeric entry (001 through 999) with zero left-fill. The purpose of the field is to distinguish one offense from another.
 (Error Message 15002)
 - 3) Must be unique -- cannot be duplicated.
 (Error Message 25001)

NOTES: Each offense in an incident is to be assigned a unique sequence number from "001" to "999".

EDIT TYPE: 12 Character Alpha

FORMAT: TT:SSS.S/P-I
 TT - Title
 SSS.S - Section
 **PPP - Subpart or Subpart with Qualifier
 or Qualifier
 or Juvenile Qualifier
 and an Inchoate Modifier if applicable would be indicated
 by a dash with a data value behind the LRS Code that
 defines the offense**

REQUIREMENTS: 1) Must be present--cannot be blank.
 (Error Message 12001)
 2) Must be a valid code on Master LIBRS/LRS Code Table.
 (Error Message 12004)

NOTES: This data element is to be used to enter the Louisiana Revised Statute Number of the offenses involved in the incident. Sections and Subparts, etc, should not be preceded by spaces or zeros. If there are no places after the decimal, then the place after the decimal and the decimal point should be omitted. The field should be left justified with no included spaces. Spaces will be interpreted as the end of the data in this field. Subparts, qualifiers, etc. must be included to be more specific on those LRS code that require these identifiers. The parts of the field can be expanded or contracted as necessary to fill in the data. (Example: Murder 14:30 would have 2 spaces before the decimal. You would drop the other space before the decimal, the decimal point, and the space after the decimal.)

All local ordinances must be reported as the appropriate state statute with any subparts, qualifiers, etc. when applicable. When a parish statute does not correspond to a state statute, the parish statute may be reported with a "P:" for the title and the parish statute following the colon. If the statute that does not have a corresponding state statute is a city ordinance, it should be reported by the police department with a "C:" substituted for the title portion of the data field, and the city ordinance following the colon. When it is a Sheriff's Office, or any other law enforcement agency who has jurisdiction in more than one city, reporting the city ordinance, it should be reported with a "C#" substituted for the title portion of the data field, and the city ordinance following the colon, where the "#" is replaced with a unique number for each city as decided by the agency and agreed upon by the state.

Any local ordinances reported to the state system will generate a warning unless the state is first told to expect these local ordinances and a description of the local ordinance has been sent to the state system so it can be classified and programmed into the state system.

No LRS codes will be accepted unless they are indicated on the **Master LIBRS/LRS Code Table**. If the LRS code is not indicated on this Master Table the incident should not be sent to the State System. If the LRS is sent before it is classified and defined on the Master LIBRS/LRS Code Table it will be rejected.

- EXAMPLES:** (1) When 14:42 is used the state program will need qualifiers to determine if the offense should be classified as a forcible rape or as a forcible sodomy. If the offense is submitted as a **14:42/V**, this would translate to a forcible rape offense and if this offense is submitted as a **14:42/A** this would translate to a forcible sodomy offense. Without any qualifiers the state program has no way to determine which offense this LRS should be reported under and the entire incident would be rejected. The agency would receive an error message that says: "This LRS Code must be submitted with a qualifier to define offense applicable."
- (2) If an incident involved a robbery (14:64) and a forcible rape (**14:42.1/V**), two Louisiana Revised Statute Numbers should be submitted. The 14:64 does not require any qualifier, but the 14:42.1 does require a qualifier.
- (3) If two females were raped in an incident, two Louisiana Revised Statute Numbers should be submitted for rape. (one LRS should be reported for each victim -- in this case both LRS codes required would be **14:42.1/V** for victim 001 and **14:42.1/V** for victim 002)

Refer to the Master LIBRS/LRS Code Table to determine: 1) LRS Codes that are accepted, 2) What offense the LRS code was assigned (NIBRS Code determines offense to be reported), 3) Index Class assigned to each LRS, 4) IBR and UCR rankings. To determine definitions of qualifiers see the list at the end of this section.

EDIT: If the LRS is submitted with a subpart and no qualifier, the agency would receive a warning message that says: "WARNING--This LRS code was submitted with a subpart and no qualifier." Check Master LIBRS/LRS Code Table to be sure the correct offense is being reported.

(WARNING # 22015)

In the Summary UCR Reporting System, the "Hotel Rule" is only applied to temporary lodging. It states: If a number of dwelling units under a single manager are burglarized, then the offenses are most likely to be reported to the police by the manager rather than the individual tenants. The burglary should be reported as a single offense. The total number of individual rooms, units, storage compartments, etc. entered is to be reported into this data element.

In LIBRS the "Hotel Rule" has been expanded to include rental storage facilities, i.e., "mini-storage" and "self storage" buildings.

- (1) A "self storage" building was burglarized and 11 rented storage compartments were forcibly entered. The number "11" (for eleven compartments) should be entered into this data element.

- (1) Investigation of a burglary complaint disclosed that the offender(s) entered the building through an unlocked street door and then forced a locked door to an office and stole a typewriter. Since one door was forced, "F" = Force should be entered.

Enter only one (1) code per Property Description Segment. Do not enter duplicate Property Description codes within one Incident unless a different Type of Property Loss code is used. An exception would be if you had more than one Drug that was Seized in the Incident. You must still follow the Mandatory Data Element Requirements.

DATA ELEMENT # 16 VALUE of PROPERTY

EDIT TYPE: 9 Character Numeric

- (1) A man purchases a new power saw from the hardware store. Later that same day someone breaks into his truck and steals the saw. The saw was purchased for \$55.73. The value of the property would be rounded to the nearest whole dollar and reported as "000000056"- \$56.00.

DATA ELEMENT # 17 DATE RECOVERED

EDIT TYPE: 8 Character Date

FORMAT: MMDDYYYY

OFFICER:**

Deputy sheriffs, municipal police officers, probation and parole officers, wildlife enforcement agents, city marshals and deputies would be considered victim type of "L" = Law Enforcement Officer.

The officer should be "in-the-line-of-duty" when victimized in order to report with this victim type of "L" = Law Enforcement Officer. The same rules that apply to the LEOKA form in UCR summary would apply to this type of victim.

This victim type can only be used for simple assaults, aggravated assaults, negligent manslaughter and murders and non-negligent homicide offenses to a law enforcement officer, that took place when that officer was on duty as a law enforcement officer.

EXAMPLE:

- (1) During a bank robbery (crime against property), the offender pointed a gun at a teller and demanded and received money. The robber also pistol-whipped a customer who stood in his way as he made his getaway from the bank.

Assuming the facts above, there were three (3) victims:
Victim 001 was the Bank which would be "F" = Financial Institution and

Victim 002 was the teller which would be "I" = Individual and

- (1) **Assault on a Law Enforcement Officer : Officer stopped vehicle on the interstate because the operator of the vehicle was speeding, not maintaining control of the vehicle, and had an invalid license plate. When stopped, the offender got out of the car and hit the officer with a club, grabbed a suitcase out of the vehicle and ran away.**

Assuming the facts above, the entries for Data Element # 31 are:

"02" = Assault on Law Enforcement Officer

"13" = One Officer Vehicle

The possible entries for Data Element # 32 are:

**"Q" = Investigating suspicious persons or circumstance
and;**

"T" = Traffic pursuits and stops

As only one (1) code can be entered into Data Element # 32, the most descriptive code (as determined by the reporting agency) should be used. In this case, the reporting agency entered a "T" = Traffic pursuits and stops.

- 1) Must be present -- cannot be blank.
(Error Message 14001)
 - 2) Must be numeric entry with zero left-fill. The purpose of the field is to distinguish one offender from another and to identify the situation where nothing was known about the number of offenders or who they were. For example, a corpse was found in a ditch and there were no eyewitnesses or other information that would provide data about possible offenders. In that case, "000" = Unknown would be entered. However, if five offenders were seen running from the scene, then five offender records would be submitted.
(Error Message 14002)
 - 3) If the incident is exceptionally cleared, then "000" cannot be entered. "000" indicates that nothing was known about the offender(s) regarding number and any identifying information. One of the criteria for exceptionally clearing an incident is that at least one of the offenders be known.
(Error Message 14057)
 - 4) For a Justifiable Homicide (09C) at least one of the offenders must have "known" information for age, sex, and race. Consequently, "000" is not valid as an offender sequence number.
(Error Message 14059)
 - 5) If the number is "000" = Unknown, no other Offender Segments can be submitted.
(Error Message 14055)
 - 6) Must be unique - cannot be duplicated.
(Error Message **14051**)
 - 7) When Data Element # 36 = "000", then Data Element # 8 must be "N" = Not Applicable and Data Element # 8A must be "88" = None.

NOTES: Each offender in the incident is to be assigned a unique sequence number from "001" to "999". - (1) A corpse with five bullet holes in it was found in an abandoned warehouse. There were no witnesses to the crime, or suspects. A single Offender Segment should be submitted with "000" entered into Data Element # 36 (Offender Sequence Number) and with no entries in Data Element # 37 through 39. **Also Data Element # 8 (Offender Suspected of Using) must be "N" = Not Applicable and Data Element # 8A (Bias Motivation/Bias Crime Type) must be "88" = None.**

- (2) Two Offenders were seen fleeing the scene of a burglary, but because they were wearing ski masks, their age, sex, and race could not be determined. Two Offender Segments should be submitted, one with Offender Sequence Number "001" and the other with "002". Applicable unknown codes should be entered into Data Element # 37, 38, and 39. **Also Data Element # 8 (Offender Suspected of Using) must be "N" = Not Applicable and Data Element # 8A (Bias Motivation/Bias Crime Type) must be "88" = None.**

DATA ELEMENT # 37 AGE of OFFENDER (at the time the incident occurred)

EDIT TYPE: 3 Character Alpha

- REQUIREMENTS:**
- 1) Must be present when Data Element # 36 (Offender Sequence Number) is other than "000" = Unknown.
(Error Message 14001)
 - 2) Cannot be entered when Data Element # 36 (Offender Sequence Number) is "000" = Unknown.
(Error Message 14052)
 - 3) When an incident is cleared exceptionally, at least one of the offenders must have "known" values in age, sex, and race.
(Error Message 14058)
 - 4) For a Justifiable Homicide (09C) at least one of the offenders must have "known" information for age, sex, and race.

 - 6) For forcible rape (11A) or statutory rape (36B), one or more of the offenders must have a different sex than the rape victim.

DATA ELEMENT # 40 ARRESTEE SEQUENCE NUMBER

EDIT TYPE: 3 Character Numeric

- REQUIREMENTS:**
- 1) Must be present--cannot be blank.
(Error Message 16001)
 - 2) Must be numeric entry of 001 to 999 with zero left-fill.
(Error Message 16002)
 - 3) Must be unique--cannot be duplicated.
(Error Message 26001)
 - 4) Number of arrestees cannot be greater than number of offenders.
(Error Message 16056)**

NOTES: Each arrestee reported is to be assigned a unique sequence number from "001" to "999".

EXAMPLE: (1) If two persons were arrested in connection with a previously submitted incident, two Arrestee Segments should be submitted--one with Arrestee Sequence Number "001" and the other with "002".

DATA ELEMENT # L40 ARRESTEE NAME

EDIT TYPE: 20 Character Alpha

FORMAT: (Last Name)(Suffix,(First Name)(Middle Name)
Suffix includes standard suffixes used to distinguish between
generations (i.e., Sr, Jr, III, II). Do not include titles (i.e., MD, M.E.,
Ph.D., Esq., etc.)

REQUIREMENTS: None

NOTES: If the full name will not fit in the field enter as much as possible. Do
not put periods behind suffix abbreviations or middle initial.

DATA ELEMENT # 41 ARREST NUMBER / LOCAL BOOKING NUMBER for ARREST

EDIT TYPE: 12 Character Alpha

- REQUIREMENTS:**
- 1) Must be present--cannot be blank.
(Error Message 16001)
 - 2) Must be left-justified with blank right-fill if under 12 characters in length.
(Error Message 16016)
 - 3) Valid character combinations can include A-Z, 0-9, and hyphens. For example, 89-123-SC is valid, but 89+123*SC or 89-123 SC is invalid.
(Error Message 16017)
 - 4) Must be blank right-fill if under 12 characters in length. Cannot have embedded "blanks" between the first and last character entered.
(Error Message 16015)

NOTES: This is the number assigned by your agency to an arrest report to identify it uniquely. It may be the "Incident Number" of a reported incident relating to the arrest or a separate booking number.

DATA ELEMENT # L45 ARREST CONNECTION to OFFENSE

EDIT TYPE: 15 Character Alpha

REQUIREMENTS: 1) Must be a valid offense sequence number. The offense segment referred to in this data element must exist.

NOTES: **This data element is optional at this time.**

This data element is used to relate the arrest with the offense which gave rise to the arrest. This also indirectly relates an offender to his victim. All offenses should be included if a charge was added for the particular offense, even those from different previous incidents.

The first three (3) characters are the offense sequence number of the offense. The next twelve (12) characters are the incident number of the offense. If Data Element # 44 (Multiple Arrestee Segment Indicator) is anything except "N" = Not Applicable then this field will be connecting arrest to offenses in two or more separate incidents. The incident number is appended to distinguish between Offense 001 in this incident and Offense 001 in a different incident. The Offense Sequence Number (3 characters) and the Incident Number (12 characters) add together to give a unique identifier (15 characters) showing which offense gave rise to the arrest. The incident number can be omitted if Data Element # 44 (Multiple Arrestee Segment Indicator) is "N" = Not Applicable. This is because all offenses will be in the same incident. And therefore, the incident number can be assumed to be that of the incident with which the arrestee segment was submitted.

DATA ELEMENT # 46 **ARRESTEE WAS ARMED WITH (at the time of the arrest)**

EDIT TYPE: 3 Character Alpha

- REQUIREMENTS:**
- 1) Must be present--cannot be blank.
(Error Message 16001)
 - 2) Must be a valid code.
(Error Message 16004)
 - 3) If more than one code entered, cannot be a duplicate.
(Error Message 16006)
 - 4) Value "01" = Unarmed is mutually exclusive with any other value, i.e., it is to be used only if no other code applies. **Note: If the arrestee was in possession of a toy or play weapon this would be reported as being "01" = Unarmed.**
(Error Message 16007)
 - 5) The third character must be "A" = Automatic or blank.
(Error Message 16054)
 - 6) If the firearm is Automatic, add "A" = Automatic as the third character of code; valid only with the following codes:
 - 11 - Firearm (Type Not Stated)
 - 12 - Handgun
 - 13 - Rifle
 - 14 - Shotgun
 - 15 - Other Firearm(Error Message 16055)

NOTES: This data element is used to indicate whether the arrestee was armed with a commonly known weapon at the time of his/her apprehension.

If the weapon was an "automatic" firearm, an "A" = Automatic is added as a suffix code, e.g., "13A" = Rifle Automatic. An "Automatic Firearm" is defined as any firearm that shoots, or is designed to shoot, more than one shot at a time by a single pull of the trigger without manual reloading.

ALLOWED ENTRIES: Enter as many codes that apply; however, do not enter the same code more than once **for the same arrestee:**

- 01 - Unarmed (If toy or play weapon or not commonly known weapon)
- 11 - Firearm (Type Not Stated)
- 12 - Handgun
- 13 - Rifle
- 14 - Shotgun
- 15 - Other Firearm
- 16 - Lethal Cutting Instrument (e.g., switchblade knife, martial arts "stars", etc.)
- 17 - Club/Blackjack/Brass Knuckles

- EXAMPLE:**
- (1) **When a man was arrested, he had in his possession a .357-Magnum handgun and a penknife. The entry should be "12" = Handgun. Because a small pocket knife is not generally considered to be a "weapon," it does not qualify for reporting to LIBRS.**
 - (2) **A female resisted arrest using a liquor bottle and a chair as a weapon before being subdued. The entry for LIBRS should be "01" = Unarmed. Although the subject used items as weapons, they were not commonly known weapons.**

DATA ELEMENT # 47 **AGE of ARRESTEE (at the time of the arrest)**

EDIT TYPE: 3 Character Alpha

- REQUIREMENTS:**
- 1) Must be present--cannot be blank.
(Error Message 16001)
 - 2) If age is under 17, then Data Element # 52 (disposition of Arrestee Under 17) must be entered.
(Error Message 16052)
 - 3) EXACT AGE:
 - A - Must contain numeric entry of 00-99.
(Error Message 16064)
 - B - A single two-character age must be in first two positions of the field. The third position must be blank.
(Error Message 16008)
 - C - When the age is unknown, don't confuse "99" = Over 98 Years Old with "00" = Unknown. Whenever "99" is entered, a warning message is produced.
(WARNING # 16041)
 - 4) ESTIMATED AGE:
 - A - Must be two (2) numeric digits, and have a trailing "E" = Estimated.
(Error Message 16009)
 - B - **If the age is reported with trailing "E" = Estimated age in Data Element # 47 (Age of Arrestee at the Time of Arrest) and the agency also reports date of birth of arrestee (DE # 47) this incident would be rejected. If date of birth is known, age cannot be estimated.**
(Error Message 26010)
 - C - The estimated age cannot be "00" = Unknown and have a trailing "E".
(Error Message 16022)
 - 5) **When Juvenile Qualifiers are used the age must be "01" - "16" for a JU:RUN - Runaway Offense (90I), JU:UNG - Ungovernable (90C), JU:CUR - Curfew (90B), or JU:TRU - Truancy (90Z).**
(Error Message 22100)

NOTES: The age of the arrestee is to be entered either as an exact number of years, an estimated age, or as unknown.

ALLOWED ENTRIES: Enter only one (1) code **per Arrest Segment:**

01 to 98 - Years Old (Age in Years)

99 - Over 98 Years Old

00 - Unknown (**cannot have "E" with this data value**)

If the arrestee's age is not known, estimate the arrestee's age and append an "E" = Estimated.

EXAMPLE:

- (1) The arrestee refused to give his date of birth, but he appeared to be 35 to 40 years old. Possible entries would be "00" = Unknown or "37E" (i.e., Estimated 37 years old). Use the latter when possible.

DATA ELEMENT # L47 DATE of BIRTH of ARRESTEE

EDIT TYPE: 8 Character Date

FORMAT: MMDDYYYY

REQUIREMENTS: 1) AGE CANNOT BE ESTIMATED IF DATE OF BIRTH IS KNOWN.

 If the age is reported with trailing "E" = Estimated age in Data Element # 47 (Age of Arrestee at the Time of Arrest) and the agency also reports date of birth of arrestee (DE # 47) this incident would be rejected. If date of birth is known, age cannot be estimated.

 (Error Message 26010)

2) AGE CANNOT BE UNKNOWN IF DATE OF BIRTH IS KNOWN.

 If the age of an arrestee (at the Time of Arrest) is reported as "00" = Unknown and Data Element # L47 (Date of Birth of Arrestee) is also reported, this incident would be rejected. If date of birth is known, age cannot be unknown.

 (Error Message 22105)

NOTES: If the date of birth of the Arrestee is known, it is to be indicated in this data element.

DATA ELEMENT # 50

ETHNICITY of ARRESTEE

EDIT TYPE: 1 Character Alpha

REQUIREMENTS: 1) If entered, must be a valid code.
(Error Messages 16004)

NOTES: The ethnic origin of the arrestee is to be entered into this data element.

ALLOWED ENTRIES: Enter only one (1) code **per Arrest Segment:**

H - Hispanic Origin

N - Not of Hispanic Origin

U - Unknown

DATA ELEMENT # 52 DISPOSITION of ARRESTEE UNDER 17

EDIT TYPE: 1 Character Alpha

- REQUIREMENTS:**
- 1) Must be a valid code.
(Error Messages 16004)
 - 2) Must be entered if arrestee age is under 17.
(Error Messages 16052)
 - 3) Cannot be entered if arrestee age is 17 or over.
(Error Messages 16053)
 - 4) Data Element # 52 was not entered, but Data Element #47 (Age of Arrestee) indicated an age for a juvenile. Note that when the age is for a juvenile, the disposition must be entered.
(Error Message 16040)**

NOTES: This data element is to be used only if the arrestee was 16 years of age or younger at the time of arrest.

ALLOWED ENTRIES: Enter only one (1) code **per Arrest Segment (for Juveniles only):**

- D - Handled Within the Department and Released (e.g., released to parents, released with warning, etc.) **(reported to NIBRS as a "H")**
- J - Referred to Juvenile Court or Probation Department **(reported to NIBRS as a "R")**
- W - Referred to Welfare Agency **(reported to NIBRS as a "R")**
- P - Referred to Other Police Agency **(reported to NIBRS as a "R")**
- A - Referred to Criminal or Adult Court **(reported to NIBRS as a "R")**

- EXAMPLE:**
- (1) The arrestee, age 13, who was arrested for vandalizing a school, was released to his parents with a warning. The entry should be "D" = Handled Within the Department and Released.
 - (2) The arrestee, age 16, who was arrested for rape, was turned over to the Adult Court to be tried as an adult. The entry would be "A" = Referred to Criminal or Adult Court.

DATA ELEMENT # L54 STATION/DIVISION/PRECINCT IDENTIFIER

EDIT TYPE: 6 Character Alpha

REQUIREMENTS: None

NOTES: This field is optional and is for the reporting agency's use in locating incidents.

DATA ELEMENT # L55 ARREST TRANSACTION NUMBER (ATN) for LOUISIANA

EDIT TYPE: 15 Character Alpha/Numeric

REQUIREMENTS: 1) Must be present if fingerprints are submitted into the Bureau of Identification of the Louisiana State Police.

NOTES: This data element will be generated by the live scan when fingerprinting an arrestee or would be a preassigned number generated and assigned at the time of the fingerprinting. This ATN number is defined as:

Characters 1-4 would be the 4th, 5th, 6th, and 7th characters of the ORI number of the agency that made the arrest or where the live scan device is housed.

Character 5 would be the live scan device number assigned to the device being used to generate this arrestee's fingerprints.

Characters 6-7 would indicate the year this arrestee's fingerprints are being scanned into this device.

Characters 8-12 would be the arrest sequence number for this arrest event. This is a number counter which sequentially assigns a number to each arrest event.

Characters 13-15 would indicate the number of charges being assigned to this arrestee at the time these fingerprints are being scanned. For instance, if an arrestee is being charged with 5 counts of aggravated battery for this arrest, the number generated would be "001" through "005."

This data element will be used to facilitate crime analysis. Arrest Transaction Number is the number assigned when an arrestee is fingerprinted on the Automatic Finger Print Information System (AFIS). This data element can be sent on every arrestee, but is only mandated if the Louisiana Revised Statute is a felony arrest or charges required fingerprints.
